

PUBLIC PARTICIPATION AT BOARD MEETINGS

Board meetings are conducted for the purpose of carrying on the official business of the school system. All regular, special and emergency meetings of the Board are open to the public. The public is cordially invited to attend and participate in Board meetings as provided in this policy.

The Board will provide appropriate opportunities for citizens to express opinions and concerns related to the matters under consideration by the Board. The intent is to allow a fair and adequate opportunity for the public to be heard and to provide adequate time for the Board to obtain information and opinion on subjects before it, while ensuring that the time allowed for public discussion does not interfere with the fulfillment of the scheduled agenda.

During the time allotted for public participation, members of the public may speak on any subject directly related to the operations of RSU 26 schools, including but not limited to RSU 26 curricula, District administration and governance, and upcoming RSU 26 events. Members of the public may not speak on personnel matters. The public will be allowed to speak using any of the modalities (e.g. in person, online) in operation for that board meeting but not modalities otherwise not in place for that board meeting under policy BEF (remote participation in board meetings)

Members of the public may address the Board within the guidelines provided in this policy. The Chair shall be responsible for maintaining proper order and compliance with these guidelines.

The following guidelines shall apply to public participation at Board meetings:

- A. Orono residents, parents, guardians or students of the school unit, and employees of the school unit are welcome to participate as provided in this policy. Others may be recognized to speak at the Chair's discretion. Individual employees and/or employee groups will not be permitted to discuss matters for which complaint or grievance procedures are provided.
- B. The Chair may limit the time allotted for comments as well as the time each individual may speak. Regardless of whether the chair sets a time limit in advance of a speaker beginning to speak, the Chair shall interrupt and terminate comments that last five minutes or longer, unless the board votes to allow a comment to continue beyond the allotted time. The Chair may require persons interested in speaking to sign up so they may be called on in a fair and efficient manner.
- C. During the time set aside for public comment, the Chair will be responsible for recognizing all speakers in the order they have signed up to speak. Each speaker must identify themselves as they begin speaking.
- D. Speakers are not permitted to share gossip, make defamatory comments, or use abusive or vulgar language or images.
- E. All speakers are to address the Chair and direct questions or comments to particular board members or the Superintendent only with approval of the Chair. Requests for information or concerns that require further research may be referred to the Superintendent to be addressed at a later time.
- F. Members of the Board and the Superintendent may ask questions of any person who addresses the Board but are expected to refrain from arguing or debating issues. Questions must be addressed through the Chair.

- G. No discussion of personnel matters will be allowed at Board meetings. No allegations, complaints, or other comments (either positive or negative) concerning any person employed by the school system or any particular student may be discussed or brought forth during public comment. Any comments or complaints concerning student or staff issues will not be considered in a public meeting and will be addressed through established policies and procedures outside of board meetings.
- H. In order to make efficient use of meeting time, the Board discourages duplication or repetition of comments to the Board. The Board requests that groups or organizations be represented by designated spokespersons.
- I. The Chair may interrupt and terminate any public comment that violates any provision of this policy, or that is personally directed towards students or employees, abusive, obscene or irrelevant. If, in the discretion of the Chair, a public comment is terminated for any of the aforementioned reasons, the person shall not be allowed to resume comment unless the Board votes otherwise.
- J. Persons who disrupt the meeting may be asked to leave, and the Chair may request law enforcement assistance as necessary to restore order. Comments in chat that violate any of these policies can result in the Chair requesting that the individual be removed from the meeting or that the chat function be turned off for the meeting..

An agenda shall be published in advance of each meeting in accordance with Board policy. Copies will be posted and/or available prior to regular meetings at the RSU 26 website. Anyone desiring additional information about an agenda item should direct such inquiries to the Office of the Superintendent.
